First off, let me apologize for the confusion from the MTDOC test of the MOU 3rd Party Notification during the DOC audit/monitoring of the Great Falls Transition Center on February 24th. I have provided the Client Advisor staff with documentation to review on the PREA 3rd Party Notification process and will be meeting with them on Thursday of this week to further provide training on the proper response to these types of calls.

Alternatives, Inc., has begun the PREA Audit process and in preparation for the audit, the Memorandum Of Understanding (MOU) between Great Falls Transition Center and Alternatives, Inc. will expire on March 26th 2022.
